**ARTICLE I- DEPOSIT**

The grantor, for the consideration herinafter mentioned, undertakes to grant to the GRANTEE, a designated cemetery plot in the Islamic Section of Les Jardins Urgel Bourgie Rive Sud located at 8145 Chemin Chambly, St. Hubert, QC, stated in Article IV hereafter for the grant identified as follows:

**ARTICLE III- BURIAL CHARGES**

- A) The parties to these presents will be subject to the conditions, rules and regulations now in force or that may be adopted in the future by the GRANTOR, and which will be considered to be of the present agreement.
- B) The grantee will become grantee "in full" only when the entire amount of the above mentioned price has been paid.
- C) In the event of the default by the grantee to fulfill its obligation as agreed in these present, the grantor and grantee will decide together as to use of the funds.

**ARTICLE IV**

- A) Lot-The The Grantee, subject to the above conditions. is granted burial rights in the designated lot and the grantor undertakes to take care of it as long as it will maintain its present function; the cost of burial being in addition to the price of grant, and shall be subject to change depending on maintenance costs. Burial costs include the transportation of the deceased person, digging of the grave and other costs as specified in the Burial cost details document prepared by the Islamic Community centre of Brossard.
- B) The use of a crypt or a niche is granted for a period of ninety nine (99) years from the date of the signature of these presents.
- C) The grantee agrees that all burials will be done in sequential order and that the granting of burial rights does not allow the assignment of any specific lot for future burial.
- D) The grantee agrees that all burials will done in the Islamic tradition followed by the ISlamic Community Centre of Brossard (following solely the Quran and Sunnah of the Prophet).

**ARTICLE V-ACT OF ALLAH S.W.T. (GOD)**

In the case of An Act Of Allah S.W.T. (God), such as an earthquake, cave-in, expropriation, etc ....., the GRANTOR undertakes to bury any human remains affected in the suitable place of its choice.

**ARTICLE VI**

The GRANTEE acknowledges being acquainted with the Law and Regulations governing Islamic Community Centre of Brossard and having received a copy of the present agreement.
